NYSCB	<ul style="list-style-type: none"> • Complete signed application • Documentation of disability • Participate in initial interview • Provide necessary reports • If eligible, work with a counselor to develop a plan for services and/or employment 	
OPWDD	<ul style="list-style-type: none"> • Phone call to DDRO • Documentation of a developmental disability • Complete Admission packet submit to local DDRO eligibility determination
